There is no doubt the past year has been a challenging one. The devastation of COVID-19, the increases in civil unrest and social injustice, and the impact of economic challenges and job loss for so many Arizonans meant assistance provided by JFCS was more critical than ever.

Recognizing the need to provide integrated healthcare to underserved communities across the Valley, in May 2020, JFCS relocated its behavioral health clinic from Mesa to the new 30,000-square-foot Gilbert location. Our new JFCS East Valley Healthcare Center now offers behavioral health and primary medical care services in one location, providing the most effective approach to caring for people in the East Valley with multiple healthcare needs.

COVID-19 accelerated our plans to bring telehealth services to our healthcare centers. Utilizing safe and secure video technology, we provided telehealth appointments to nearly 3,000 patients each month, up from 300 per month the previous year. Telehealth will continue to be at the forefront of our integrated health delivery, as it eliminates the many barriers to receiving proper care.

Protecting our staff and the people we serve is paramount to everything we do. Therefore, JFCS was certified by HealthyVerify, the country's only medically based, scientific, and professional full-service certification company that helps organizations minimize the risk of transmitting infectious disease. JFCS demonstrated its implementation of disease-reducing procedures, creating a safe and healthy environment for everyone that visits a JFCS location. JFCS was Arizona's first behavioral health organization to be certified by HealthyVerify.

As an agency that works with vulnerable populations, JFCS continuously adapts our programs to meet critical needs. Our staff is committed to providing vital services that provide a lifeline of support for our community. With your help, JFCS works to achieve our mission each and every day. And because of you, more than 40,000 individuals throughout Maricopa County are stronger, cared for and safe.

JFCS East Valley Healthcare Center evolves into state of the art integrated healthcare facility

The JFCS East Valley Behavioral Health Clinic moved into a new, larger location in March, 2020. The new facility includes a full-service primary care medical wing. The new JFCS East Valley Healthcare Center became JFCS' third integrated healthcare facility offering both mental health and primary care services in a single location. Integrated care is the most effective approach to treating individuals with multiple healthcare needs.



Hospital Chaplains work with patients and families

Despite the many restrictions throughout COVID-19, our JFCS Hospital Chaplains continue their spiritual care in 26 valley hospitals. We welcome the opportunity to speak directly with patients and their families who wish to receive Jewish/rabbinic support during their hospitalization. Working in partnership with the hospital chaplains, the JFCS Chaplains are able to fulfill our care and compassion responsibilities and commitment to the Jewish community.

Shelter Without Walls and Sojourner Center address increased domestic violence incidents



Our community faced many new challenges as a result of the COVID-19 pandemic. Many lost jobs or saw a reduction in hours, leading to increased financial stress. Essential workers faced increased exposure to the virus, multiple quarantines, or sadly, contracted the virus. We saw increases in incidents of domestic violence as abusers had a new tool, the virus, to manipulate, threaten and coerce their victims. Through it all, JFCS Shelter Without Walls and Sojourner Center were there to provide critical support.



When Mary attempted to leave her abusive relationship, she found herself going to countless custody and court hearings. With the help of a JFCS Domestic Violence Advocate, Mary did not have to go through this experience alone. "The court hearings were one of the scariest places to be by yourself. My JFCS advocate looked at me and said, 'I believe you.' And, those three little words were what I needed to hear."

Family Preservation, Family Reunification and Parent Aide Programs add virtual services



2020 was full of new experiences and new challenges for JFCS Homebased Services. The Governor's stay-at-home order was in place and the Arizona Department of Child Safety (DCS) asked all homebased programs to conduct services virtually. Although far from ideal, we saw many unexpected benefits. Parents who were not able to be physically with their children were now able to establish an even greater bond with their children through video visits. We also saw enhanced relationships between parents and out-of-home caregivers. This type of shared parenting is extremely beneficial in reducing the trauma children experience while in out-of-home care.



Children at risk of removal from their home continued to receive in-person services from JFCS, at their home. Staff observed all social distancing and hygiene protocols and did an excellent job in overcoming fears and barriers while ensuring that children remained safe in their homes. Despite restrictions of COVID-19, Homebased Services continues to meet the needs of the clients we serve, partnering with DCS to assist in the challenges and changes.



Out of the 40,049 lives touched through our integrated health and social services programs, 64% were children and teens.



Center for Senior Enrichment launches virtual senior programs

In March 2020, the JFCS Center for Senior Enrichment (CSE) in-person classes were shut down due to the pandemic. At that time, seniors were required to remain in their homes in order to stay safe. This meant the social interaction and mind stimulation that seniors once had at the Center were no longer available for the foreseeable future.

After a few months of living in the pandemic world, Jennifer Brauner, director of the JFCS Center for Senior Enrichment, proposed a new "virtual" Senior Center.

Online classes are now available on ZOOM for free to ALL seniors in Maricopa County. Going virtual provided the flexibility to offer programs that had not otherwise been available to seniors.

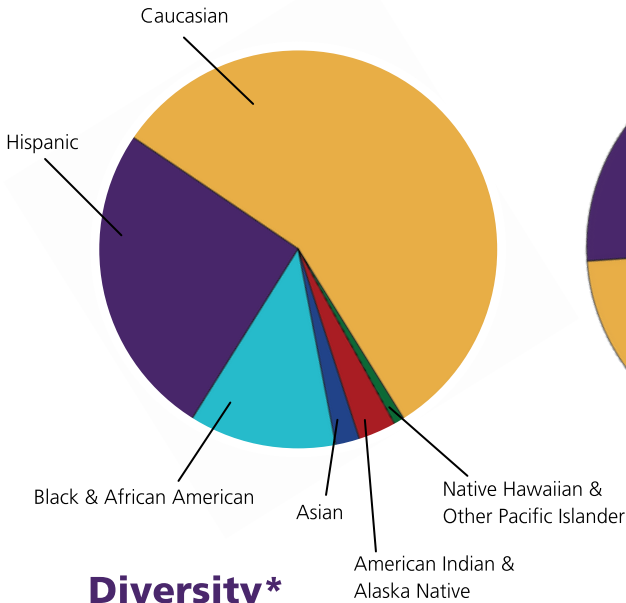
Individuals appreciated the virtual platform, and participants shared the program with others. In 2020, the JFCS virtual senior center had more than 2,000 visits. Each week we average 20-30 new participants. As hoped, this new expanded program is a gift to the senior community.



The JFCS Virtual Senior Center had more than **2,000 "visitors"** experience online classes.

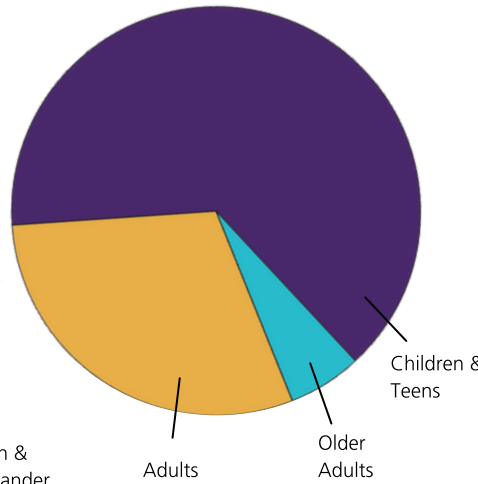

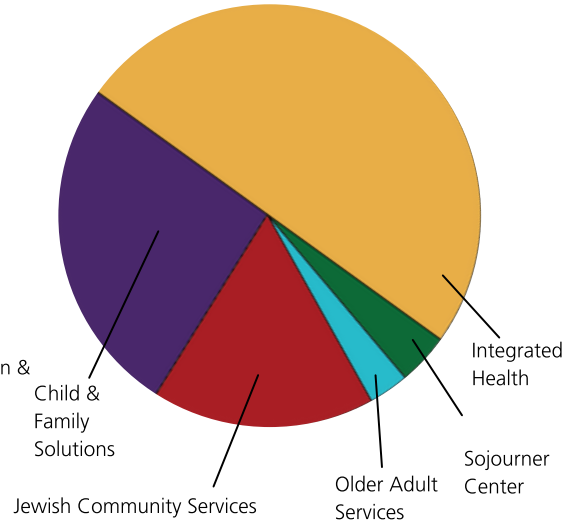

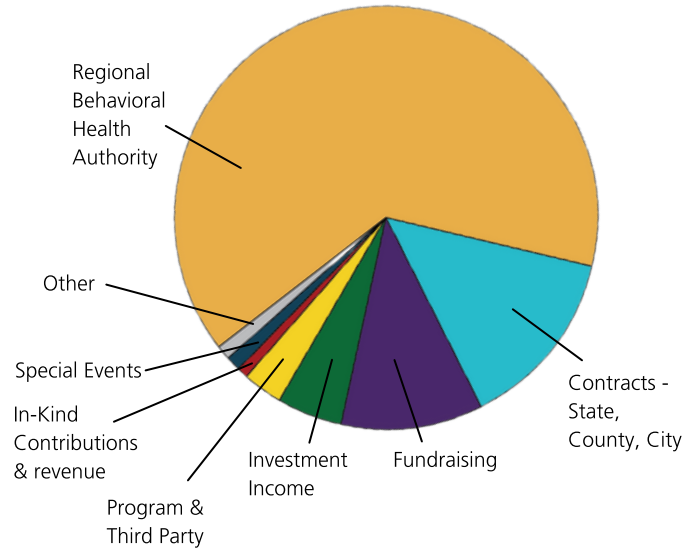

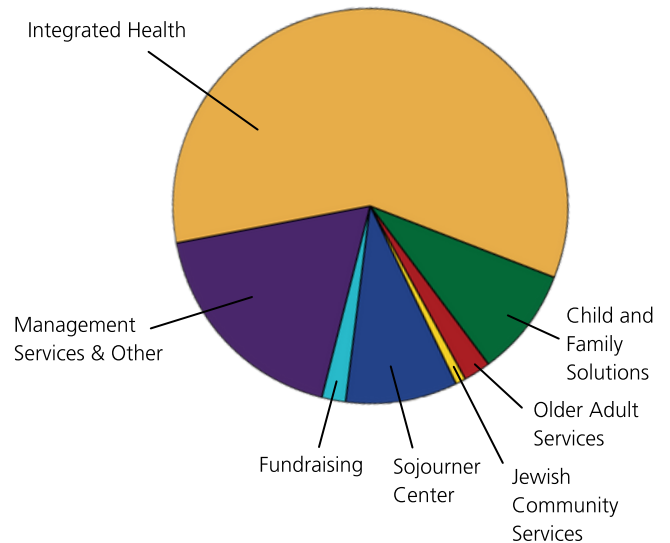
